

## Data Privacy Policy

At Cimtek UK, we're committed to protecting and respecting your privacy.

This Policy explains when and why we collect personal information about people who visit our website, how we secure it, the conditions under which we may disclose it to others and how we keep it secure.

We may change this Policy from time to time so please check this page occasionally to ensure that you're happy with any changes. Your continued use of our website(s) after posting will constitute your acceptance of, and agreement to, any changes. By visiting this website, and filling in a response form, or providing your personal information to one of our employees, you are accepting and consenting to the practices described in this policy. Please note that this includes consenting to the processing of any personal information you provide, as described below.

For the purposes of the Data Protection Act 1998 (the Act), the data controller is Cimtek UK Limited. Cimtek UK Limited is part of the Circuit Check, Inc. group of companies, comprising Circuit Check, Inc. and its subsidiaries (collectively "CCI" and, individually, a "CCI Company").

This policy (together with our terms of use and any other documents referred to in it) sets out the basis on which any personal information we collect from you, or that you provide to us through our website or via one of our salespersons, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal information and how we will treat it.

### Who are we?

We are Cimtek UK Limited, a subsidiary of Circuit Check, Inc. a global leader in supplying electrical test systems and fixtures to electronics industry. Cimtek UK has a business address of Unit C9 Endeavor Business Park 7 Penner Road Havant UK P09 1QN.

### How do we collect information from you?

We obtain information about you when you call on us directly, are referred by a partner or fill in response forms on our website.

### **What type of information is collected from you?**

The personal information we collect might include your name, business address, and email address. We don't collect credit card or other payment information via our website.

### **How is your information used?**

We may use your information to:

- Provide information regarding our products and services;
- Tailor proposals for your consideration;
- To carry out our obligations arising from any contracts entered into by you and us;

### **Information we may collect from you**

We may collect and process the following information about you:

- Information you provide to us

You may provide us with information by filling in forms on our website(s) or by corresponding with us by phone, e-mail, live-chat or otherwise. This includes information you provide when you register for an account, search for a price comparison or quote, enter into a contract for the supply of services, enter a competition, promotion or survey and when you report a problem with our site. The personal information you provide may include your name, business address, e-mail address and phone number. By providing us with this information, you expressly consent to our use of your personal information in accordance with this privacy policy.

- Information we collect about you

When you visit our website(s), we may in the future automatically collect information about your computer, including your IP address, information about your visit, your browsing history, and how you use our website via cookies. This information may be combined with other information you provide to us, as described above. This information would help to provide you with a good experience when you browse our website and also allows us to improve our site.

- Information we receive from other sources

We may receive information about you if you use any of the other websites we, or our group companies, operate or the other services we provide. We are also working closely with third parties (including, for example, business partners, service providers, advertising networks, analytics providers, and search information providers) and may receive information about you from them. This may be combined with other information you provide to us, as described above.

### **How we use your personal information**

We use personal information about you in connection with the following purposes:

- Fulfilling your requests:
  - to provide you with the information, products and services that you request from us or another CCI Company, including providing you with price comparison quotes and switching services;
  - to complete any transaction you are undertaking with us or another CCI Company;
  - to administer any promotion or competition that you enter via our website(s); and
  - to allow you to participate in interactive features of our service, when you choose to do so.
- Marketing:
  - to provide you with information about other goods and services we or other CCI Companies offer that are similar to those that you have already purchased or enquired about;
  - to provide you, or permit other CCI Companies;
  - to measure or understand the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you, which may be based on your activity on our website(s) or the website of another CCI Company or third parties' websites; and
  - to make suggestions and recommendations to you and other users of our site about goods or services that may interest you or them, which may be based on your activity on our website(s) or the website of another CCI Company or third parties' websites.

- Service Improvements and account management:
  - to ensure that content from our site is presented in the most effective manner for you and for your computer.
  - to administer our site and for internal business administration and operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
  - to notify you about changes to our service and to send you service emails relating to your account;
  - as part of our efforts to keep our site safe and secure; and
  - to manage and operate your account with us.

### **Sharing your personal information**

We may share your personal information in connection the purposes described above with any other CCI Company.

We may also share your personal information with third parties in the following circumstances:

- Selected insurers, insurance brokers, and other related third parties, to enable us to obtain support for our services provided to you. Their use of any data we provide will be governed by their own terms of use and privacy policy. Such information can be provided upon request.
- Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you.
- We may also share your personal information with third parties:
  - In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets, along with its professional advisers. If Cimtek UK Limited or substantially all of its assets are acquired by a third party, personal information held by it about its customers will be one of the transferred assets.
  - If required in order to obtain professional advice.
  - If we are under a duty to disclose or share your personal information in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of Cimtek UK, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection.

### **Where we store your personal information**

The information that we collect from you may be transferred to, and stored in, a country outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. The laws in some countries may not provide as much legal protection for your information as in the EEA. By submitting your personal information, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal information, we cannot guarantee the security of your information transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorized access.

### **Cookies**

Our website has deactivated tracking for any user coming from UK or EU IP address.

### **Opting Out of Collection of Information by Third Parties**

Cimtek UK Limited currently has no third-party using cookies, web beacons, clear .gifs or similar technologies.

### **Your rights**

You have the right to ask us not to process your personal information for marketing purposes.
